The Greater Philadelphia Area Counseling Association has been building membership and designing programs for local professional counselors and counseling students. On Saturday March 4<sup>th</sup>, 9:30 – 12 noon at Drexel University, we hosted a networking event featuring a workshop on *Trauma Informed Advocacy*, presented by Minna Davis, PCA & GPACA member This workshop brought 40 professionals and students together, resulting in many new memberships and ideas for future programming.

In April, we are collaborating with the American Red Cross and Chestnut Hill College to deliver a four-and-a-half-hour training on *Disaster Mental Health*. John Weaver, LCSW, Disaster Mental Health Volunteer and Mid-Atlantic Division Advisor, will be leading this workshop.

The Government Relations Committee has an active role in the ad hoc committee for amending language in the PA Title Protection Act for LPCs to make it a stronger Title Protection and Practice Act.

Specifically, five members, Nellie Scanlon, Kristen Hawk, Kurt Kraus, Travis Schermer, and Lauren Ostrowski, have been working with members of the Executive Committee and the representative from the Lobbying Firm Wooten & Malady to clarify what constitutes the practice scope of LPCs based on the ACA's 20/20: Vision for the Future of Counseling project definitions and the PA State Board regulations.

We are following in suit with what the Social Workers have already proposed in the current House Bill 445 and with what the Marriage and Family Therapists are looking to do as well.

Strengthening our Title Protection and Practice Act will enable us to continue to provide quality care and treatment to our clients.
